5. Consumer data and health information

Partners must not expect a consumer clinical health dashboard on the public marketing site. Any partner access to operational data is limited to programme-approved scopes (for example shop inventory they own, referral attribution aggregates). Partners must not attempt to harvest consumer health records through LoomaVita systems.
